# **Summary of the Management Committee Meeting**

**Participants:** Jeremy Perling, Eviatar Assaf, Uri Gilad, Elad Ilan, Doron Kagan, Idan Zelas, Inbal Pezaro, Limor Griman Agenda:

- 1. Approval of the minutes of the Management Committee meeting from 12/5/2025.
- 2. for Assembly and Economic Council Procedure update (Invitees: Assembly Committee Shlomo Cohen, Eddie Solow)
  Following the approval of the new regulations of Kibbutz Ylzrael, adjustments to various procedures are required.
  An updated draft of the Assembly and Economic Council procedure was presented for the Management Committee's approval ahead of its submission for the assembly's approval.

The procedure changes are in keeping with the new Statutes (Takanon HaKibbutz).

#### 3. Discussion:

- Regarding records of meetings: the question arose as to who is permitted to view the records of closed meetings (e.g., membership admissions). It was decided that this is not part of the assembly procedure. Rules need to be formulated regarding handling private information and its disclosure in general in all the kibbutz forums.
- Publishing voting results in cases of personal voting (candidates for various
  offices and acceptance of new members): it was decided that the Assembly
  Committee will not publish results when voting for office bearers; interested
  candidates may receive results privately. For votes related to membership or
  candidacy, results will not be disclosed to the candidate unless the member
  was not accepted.
- The procedure lacks guidelines regarding other topics with which the assembly deals. These rules exist in various decisions but are not consolidated into a single document. Uri Gilad and Eviatar Assaf will gather information and prepare a proposal for the next Management Committee meeting.
- 3. Amendments to the Life Fund Procedure and Pension fund Procedure a. Following a previous discussion on the 12/5/25, Elad Ilan, Chair of the Reserve Fund, presented a proposed change in the pension fund, mainly altering the actuarial debt calculation method for Reserve Fund members. The issue was examined by the absorption Committee, which found the change feasible and likely to have a positive impact on absorption. The Management Committee added a clause: "the calculation method will be the same as the pension debt in all cases."

The proposed change will be submitted for assembly approval.

b. Regarding the Life Fund — the Reserve Fund management requests to extend the period within which the fund must pay the deceased's heirs the remaining balance, from 30 days (current in the procedure) to six months. The reason relates to index calculations and checking the deceased's situation with the kibbutz in other areas (budget debt, apartment condition). The Management Committee approved this change. The proposal will be submitted to the assembly for approval.

#### 4. Miscellaneous and Updates

a. Limor reported to the Management Committee about the community's emergency procedures, from the start of the campaign against Iran. The committee members were briefed on issues handled by the home security committee: inventory checks and replenishment, shelter maintenance and equipment (with regional council support), ensuring continuity of essential services, and mental well-being.

Additionally, with the regional council's assistance, requests were submitted for four mobile bomb shelters (two for agriculture and two for the community), expanding the kibbutz's protection measures.

- b. The mediation process between Yonatan Orozco and the kibbutz concluded successfully, reaching a mutually satisfactory agreement.
- c. An appeal by the Nanikashvili family in one of the lawsuits was dismissed by the Supreme Court regarding a decision of the District Court in a legal case involving them and the kibbutz.
- d. The Nanikashvili family filed another lawsuit against several role holders and kibbutz members for defamation. An attempt at mediation was made but was unsuccessful.
- e. In a ruling by the Magistrate's Court, the lawsuit by Asahel Mor against former role holders was dismissed.

# **Summary of the Community Management Meeting**

 Review of the kibbutz's conduct during a state of emergency amid the war with Iran

Limor and Erez reviewed the management approach and decision-making processes starting Friday, 13/6, when hostilities began and we entered a state of alert.

checking and completing inventories in various areas, maintaining and equipping shelters, ensuring continuity of essential services, and attending to mental well-being.

The management team was involved in dilemmas primarily revolving around the tension between providing essential services within the kibbutz and the strict and comprehensive guidelines from Home Front Command.

It was also noted that it is clear to us that the period of staying only at home will lead to increased household expenses—electricity consumption and food costs, but there will be savings in other areas.

At this stage, it is still too early to make decisions; once we can assess the situation and gather data, this matter will be brought for discussion.

2. Presentation of the community's four-month budget performance and an estimate for the end of the year (guest: Niv Harmoni – financial officer). Based on data from January-April 2025 and analysis on a monthly basis with department managers, the forecast for the year's end indicates a balanced performance relative to the approved budget.

Various trends in different sections were presented, but the overall picture remains consistent.

# What's Happening in the Reserve Fund

In these days of Gog and Magog, we would like to share a little about what's brewing and happening in the Reserve Fund's yard.

First, let us remind you that the Reserve Fund, or in its full name, "The Reserve Fund for Members of Kibbutz Ylzrael," is a cooperative society established by the members of Kibbutz Ylzrael to address several aspects of social security. The main aspect is the kibbutz's obligation to pay pensions to its members, both according to law ("Registrar's

Pension") and based on the assembly's decision through the Social Security Procedure (= Pension Procedure), which defines the target pension for kibbutz members.

Like any cooperative society, the Reserve Fund holds general meetings of all its members (notably an annual meeting to approve financial reports, an auditor's review, appointment of an audit committee, and other topics). The fund has an elected management committee that meets quarterly and a manager responsible for the fund's operation in all its aspects (Natasha). To ensure pension payments, we rely on a pension broker and an actuarial advisor. Members sign power of attorney documents, allowing the broker and advisor access to information about their pension assets registered in pension and insurance companies.

To fulfill the kibbutz's pension obligations to its members, the Reserve Fund also utilizes contributions to pension savings instruments (pension funds, provident funds, study funds) in the members' names. In the past, there was "kibbutz member"—a general account belonging to the kibbutz. Today, contributions to these instruments are only made in the members' names. For outside workers, these contributions are made by law by the external employer, while for members working within the kibbutz or on invoices, the Reserve Fund makes the deposit.

It's important to remember that all savings and rights in these instruments, generated through members' work belong to the Reserve Fund and serve as a source for fulfilling the kibbutz's commitments to its members. All members have signed a commitment letter with the Reserve Fund and the kibbutz, detailing the obligations and actions required from the member to enable the fund to perform its duties.

Currently, we are working on preparing the society's financial report for 2024, which is undergoing an accountant's review and will be presented at the members' meeting. The bottom line of the report should provide members with an accurate, as possible, picture of the actuarial liability (i.e., the amount the kibbutz/the fund needs to fulfill the target pension for members) versus the assets allocated to the fund (mainly pension assets registered in members' names).

To prepare this report, we conduct a kind of "inventory count". We start with a report generated from the Pension Clearinghouse of the Ministry of Finance \*, showing the balances in all the members' accounts (thousands of lines) at the end of the calendar year. For proper account management, we also access each fund (mostly automatically, and manually for some) and record the financial movements during the year: opening balance, deposits, withdrawals, profits, management fees, etc. This ensures high reliability of the data in the financial report.

For most of the members' funds, we can receive consolidated reports through our pension broker. However, there are nearly a thousand funds that require members' cooperation to access the annual report. We thank the members in advance and retrospectively for their cooperation. It should also be noted that, despite the caution and healthy suspicion some of us have in sharing personal information, these funds do not constitute the member's personal asset—the member is merely the "representative" of the Reserve Fund for savings purposes.

Sometimes, the clearinghouse also shows members' private assets, such as investment savings accounts, which are personal savings instruments, or other pension assets belonging to the member but not part of the Reserve Fund. For these, the Reserve Fund has no interest beyond knowing the private account details (as per section 6 of the commitment letter we signed) to exclude them from the account. However, it should be known that the clearinghouse contains the balance data also for private accounts. All this data is accessible only to the Reserve Fund staff, the pension broker, and the actuarial advisor, who are bound by confidentiality.

That's all for now. As usual—if you have questions, requests, or need clarifications—we are at your service.

\* From the Government Clearinghouse website (MIslaka): "A system connected to all insurance companies, pension funds, severance pay funds, and study funds, through which savers can easily obtain a complete pension overview: which entities and in which accounts/policies I have funds, the total amount accumulated in various savings, my contributions, coverage for death and disability, a forecast for retirement age, and more."

- Adoption and support of a kibbutz in the Gaza Envelope (we chose Kibbutz Re'im). Yifat, Nitzan, and Tzafnat.
- Support and accompaniment of the observers serving at the Jalame checkpoint. Eyal and Gazit.
- Agricultural volunteering to assist communities affected by the war and farmers serving long-term reserve duty. Niv and Tzafnat.
- Hosting children and youth at risk, at the pool. Adi.

In the coming months, we will begin implementing the various projects, and after a "pilot period," we will start thinking and drafting our work procedure and additional activities.

Of course, the ability to successfully execute these projects depends on community cooperation. We would be grateful if you could register via the questionnaire sent through Kehilanet, indicating your preferred volunteering fields, or contact the project leaders directly. Through the questionnaire, we aim to map the community's perception of volunteering, so we would appreciate as many responses as possible.

Thank you very much, and may we always be on the giving side.

# It's Always a good time for coffee **Dalia Levitan Interviews Naomi Amit**



We are sitting here, in this magical place, among the trees, calves, and the scents of coffee, relaxing from the storms raging outside. Around us, there's an inviting plant nursery, a children's relaxing from the storms raging outside. Around clothing shop, a ceramics studio, and a bakery—

all housed in old huts painted in calm pastel colours. It's a pastoral, village-like atmosphere.

A few months ago, the café celebrated its 8th birthday. This is a fitting time to reflect on where we came from and where we are headed. Therefore, an interview was conducted with Naomi. It's worth noting that the interview took place during a troubled period, and we hope good times will soon return.

#### Naomi, tell us how and when it all started

After many years at Maytronics, where I held various roles, I felt a desire and need to find a pursuit close to my heart. It's something I had dreamed about for many years. During my work at Maytronics, I would occasionally visit the Provence region, France, where I was exposed to small, charming cafes in villages. I thought, how fitting it would be for us to have such a place: a quiet, homely, and inviting spot with a pastoral atmosphere.

#### When did the dream begin to become a reality?

About nine years ago, I applied to open a venture. Not everyone was immediately enthusiastic, and some raised an eyebrow, but the venture got underway. From the approval to opening the café, exactly one year passed—a year of defining, deliberating, searching for a direction, and planning.

#### What kind of staff did you build?

When I opened, I naively thought that one and a half people would suffice, but it quickly became clear that reality was bigger than the dream, and we are now a team of four full-time workers. Simultaneously, we built a team of volunteers—retired members and residents—who have been working with us faithfully and with commitment to this day.

#### Who was your target audience?

When I first opened the café, the hours were longer, and the menu was more extensive. We offered a diverse menu of vegetarian lunches, so we also attracted people from Maytronics, as well as casual and local visitors. It turned out that the unpredictable is the most constant thing here. I learned this along the way. Then came the COVID-19 pandemic, which created a new reality and forced us to make major changes—some of which are still with us today.

We learned the limitations of the space and the kitchen, which caused us to change many things: the opening hours were adjusted, and with the change in hours and menu, the clientele also changed. Today, most visitors to the café are outside guests, but naturally, many locals—adults and young people—visit as well. The place gives us the opportunity to meet different populations of all ages, and we are happy to see everyone.

#### How do you reach people? How did they hear about you?

We launched a Google Maps website, a Waze page, and have a Facebook page that is updated daily. We also advertise on Kehilanet, and mostly, we rely on word-of-mouth.

#### How do you operate the café today?

The current hours and menu are a direct result of the available staff. We haven't been able to find enough people to work full-time and consistently. Still, we would like to open more hours with a richer menu, but physically, the place is very small. Inside, we have limited seating, but there are many nice outdoor seating areas. Although it's beautiful and inviting outside, people prefer sitting indoors. Therefore, if we want to preserve the intimate atmosphere, we have to ask visitors to book in advance.

#### Why are there so few seats inside the café?

The hut area where the kitchen is located isn't suitable for sitting around tables, mainly due to space constraints, noise, and poor acoustics. We have placed near the kitchen a selection of nice accessories that visitors can enjoy and purchase.

#### What are your plans for the future?

We would like a permanent staff and the possibility to expand and increase the seating inside the café by another 15-20 seats. The place wouldn't have sustained itself without the memberss who feel committed and responsible for it—many thanks to them!

In conclusion, Naomi emphasizes how important it is for her to maintain the café as an intimate and quiet meeting place—a breather over a cup of coffee (or anything else from the menu) in the middle of the day. Naomi hopes that visitors will leave feeling relaxed, pleased, and craving more. When guests thank us for serving them, we correct them and say—

We didn't serve you; we hosted you. Interview and article by: Dalia Leviathan






# **New Books in the Library - June 2025**




